

Canadian Visit Visa Requirements

To attend the WiN Global conference in Canada you may require a Temporary Resident Visa (TRV).

Check here to see if you are from a country that does require this documentation.

If you do require a TRV, individuals applying must pay a fee for the application (\$75 for single entry, \$150 for multiple entry—Canadian Funds).

Key Information that will be required to support your application includes the following:

1. **Doctor's Examination:** (letter from a Doctor recognized by Canadian missions abroad) indicating subject is of good health. This letter must be obtained only if the subject has resided in one of the countries listed as a "designated country/territory" for greater than one year—a list that includes most countries of the world.
2. **Valid Passport/travel documents:** Applicants wishing to enter Canada must have valid travel documents and/or a passport. This is simply used to verify who the applicants' identity.
3. **Letter of Invitation:** The letter of invitation must include the complete name, date of birth, address and phone number of host, occupation, relationship to applicant, purpose of trip, intended length of stay, details on accommodation and living expenses, and the arrival/departure dates of the visitor. The more information provided, the better. An itinerary of the proposed visit is particularly helpful.
4. **Financial documentation:** Generally speaking, Immigration officers require the last 6 months' bank statements of individuals applying for a visit visa. Officers are merely looking for proof that applicants have the resources necessary to support their visit to Canada.
5. **Proof of ties to country of current residence/origin:** Any documents that can be provided to Immigration officers that indicate beyond reasonable doubt that the applicant has reason/obligation to return to the country of origin/residence are particularly helpful. This includes papers documenting ownership of property, assets, etc.
6. **Family whereabouts documentation:** If applicants have family members living in Canada or family members abroad, it is helpful to our officials abroad to list their vital statistics, whereabouts, occupations, and often financial statements.
7. **Letter from Employer:** A letter from the applicants' employer granting leave of absence and indicating the name, position, and currently salary of the employee is required. The letter must also include the employer's name, address, and contact information.
